Not included in the fee are round trip international airfare, meals other than those specified, laundry service, gratuities, and other items not specifically mentioned as included.

While MARY PADGETT FINE ART LLC will do everything possible to maintain the listed tour price, that price does include energy expenses incurred at *La Casa Gialla* and transportation costs for touring within Tuscany. These costs are based on current energy expenses. If there is a fluctuation in oil and energy prices, a fuel/utility surcharge may be added to your tour fee. Participants on this tour must be in good physical condition. You must be able to walk, without assistance, a minimum of two miles over uneven terrain like cobblestones and climb stairs that may not have handrails.

It is recommended that participants obtain travel insurance. MARY PADGETT FINE ART LLC accepts no liability for the purchase of non-refundable airline tickets or other travel-related tickets and expenses if the tour is cancelled or modified after the tickets are purchased or expenses incurred.
